While August's power generation in several areas in Tohoku, Kanto, and Kinki region are slightly below the expected power generation, however, increased monthly sunshine duration throughout the nation resulted in electricity generation to reach 8,528,178kWh, which is 5% higher than the estimated electricity generation on the basis of the expected amounts of electricity generation in the 50th percentiles of probability of exceedance.

(Note) The estimated electricity generation is the total of the expected amounts of electricity generation in the 50th percentile of probability of exceedance calculated by a third party on the basis of the database for hourly solar radiation for a year and others
